Students must provide documentation of services for AAA Northwest Ohio Safety Patrol, good academic standing and a strong record of community participation and extracurricular activities.

APPLICANT QUALIFICATIONS

1. Must be a graduating high school senior of a public, private or parochial high school, or private preparatory school within the servicing area of AAA Northwest Ohio** under such reasonable and non-discriminatory rules and regulations as are formally developed by the Committee.
2. Participation as a Safety Patroller within the servicing area of AAA Northwest Ohio.
3. Acceptance into a post-secondary institution.
4. A strong record of participation in the community and extracurricular activities.
5. Good academic standing; a cumulative grade point average of 3.0 or better.
6. ACT score of 21 or better and/or SAT score of 950 or better.

STUDENT INFORMATION

Student should submit the following information with an application to the school guidance counselor. The counselor will then forward qualified candidates to AAA Northwest Ohio (address is below).

- A letter of recommendation from a school teacher, Guidance Counselor or Principal. One page typed, double spaced on 8 1/2 x 11 paper, 250-300 words.
- A letter of recommendation from a community representative (e.g., youth leader, employer or other). One page typed, double spaced on 8 1/2 x 11 paper, 250-300 words.
- Personal essay providing a brief description of the following: community participation, extracurricular activities (hobbies), the meaning of being a Safety Patroller and how the Safety Patrol experience influenced your life.
- List of awards, honors and/or recognitions (please provide dates).
- Copy of acceptance letter into a post-secondary institution.
- Official copy of high school transcript with a G.P.A. of 3.0 or better.
- Copy of ACT or SAT test scores.
- Documentation of participation in AAA Northwest Ohio's Safety Patrol Program (a letter written by the Principal, Safety Patrol Advisor or Superintendent is acceptable).
- Parent's/Guardian's signature.
- School Principal or Guidance Counselor signature.
- College or institution you are planning to attend.
